4) Executive Report

F. Sadid spoke on a number of issues: There was a big turnout for ASSU's award ceremony – we have a very accomplished community in our Faculty. He raised the idea of having alumni networking events within the Faculty – the Dean is working with the Advancement team and has said that they will provide funds to support Departments that need it for these types of events. He met with the Faculty to discuss the findings of the CR/NCR survey, specifically that students wanted to have the option available to them after they received their final grades. The Faculty were willing to consider this, if all three campus agreed. In regards to the Speaker Series, it will not happen this year, as organizing went too slowly. He met with the UofT Working Group on Sexual Violence Policies – where he proposed two things: make clear the disciplinary and investigative action that will be pursued and set the tone, firmly, during orientations to preemptively address the matter. Finally, Robarts will be extending their hours until 2 am during the final exam period.

- M. Wong reported that the URC went well with 6 guest speakers and 60 student presenters. She thanked J. Seto for her help with the organizing of the day's events.

F. Kayed reported that it was a competitive year for our ASSU Awards. In regards to the issue she has been working on this year, the percentage of returned work before the drop date, the Dean's office do not want to mandate a specific percentage. However, we feel it would be good to have a suggestion in the handbook.

S. Zaman thanked those who attended the URC. She talked about the accessibility issue within departments – she met with the SOC Department to address accommodation issues. ASSU and CUs should continue to keep an eye out on this issue.
